This legislative rule establishes regulations to govern use of public shooting ranges located on state wildlife management areas, state forests, and on other private or governmental entities in which the Division holds a cooperative management agreement.

This rule remains necessary to address numerous issues that were experienced on the wildlife management areas and public shooting range, including target shooting in non-designated areas, use of explosive targets and inappropriate ammunition which have created public safety issues.
