- B. Economic Impact on Political Subdivisions; Specific Industries; Specific Groups of Citizens: A reduction of \$72,000.00 in expected revenue to the agency. Proposed fee for two license classifications is expected to be \$8,000.00 annually. A dramatic savings to the fireworks industry and the general public by reducing the costs associated with indoor and outdoor firework displays.

This rule establishes the agency fee schedule as authorized by State Code 29-3-12b 2002. This rule directs revenue beginning July 1, 2004 to the Special Revenue Fund. Current statutory requirements, under State Code 29-3 will be funded from the Special Revenue Fund.

CIRCUMSTANCES:

To correct an error by the agency, Emergency Rules have been filed to reduce the authorized fees for pyrotechnicians from \$200.00 annually to \$20.00 annually. No other changes have been submitted or are requested.
