

**Statement of Circumstances**

The proposed legislative rule is needed to qualify the necessary education and work experience required to be licensed as a registered forester or registered forestry technician. It also is required to establish meeting dates, procedural structure for Board actions and licensure, continuing education requirements and code of ethics provisions.

**§200-1-1. General.**

1.1. Scope and Purpose. -- This rule of the state board of registration for foresters is for the purpose of interpreting and implementing W. Va. Code §30-19-1 et. seq., establishing the Board and conferring upon it responsibility for the registration of foresters and the regulation of the practice of professional forestry.

1.2. Authority. -- W. Va. Code §30-1-4 and §30-19-6.

1.3. Filing Date. --

1.4. Effective Date. --

**§200-1-2. Qualifying experience.**

2.1. Registered professional forester - - An applicant for registration relating to the qualification and registration of professional foresters must have (1) a bachelor's degree in forestry from a four (4) year school, college or university accredited by the Society of American Foresters and at least two (2) years of full-time equivalent work experience as a professional forester within the ten (10) years preceding the date of filing an application for registration; or (2) a master's degree in forestry, which is expressly found to fulfill or exceed the requirement of a bachelor's degree in forestry, fulfilling course work required for accreditation by the Society of American Foresters from a school, college or university accredited by the Society of American Foresters and at least two (2) years of full-time equivalent work experience as a professional forester within the ten (10) years preceding the date of filing an application for registration; or (3) an associate's degree from a two (2) year technical forestry program recognized by the Society of American Foresters plus a bachelor's degree in another natural science or business and at least four (4) years of full-time equivalent work experience in the field of forestry acceptable to the board within the ten (10) years preceding the date of filing an application for registration.

Registered forestry technician - - An applicant for registration relating to the qualifications and registration of professional forestry technician must have an associate's degree from a two (2) year technical forestry program recognized by the Society of American Foresters and at least four (4) years of full-time equivalent work experience in the field of forestry acceptable to the board within the ten (10) years preceding the date of filing an application for registration.

2.1.a. Qualifying work experience acceptable to the board is employment that includes both of the following: Employment on a full-time basis, or, at the discretion of the board, equivalent part-time experience, with (1) a business that provides professional forestry services, that is in good standing with respect to all lawful obligations imposed by state and federal law, that employs at least one (1) registered professional forester in a supervisory position in West Virginia or (2) a unit of the state or federal government that provides professional forestry services and employs at least one (1) registered professional forester in a supervisory position in West Virginia; and

2.1.b. Actual job responsibilities, under the supervision of or in consultation with a registered professional forester, that include, on a regular basis, at least four (4) of the following:

2.1.b.1. Consultation with respect to forestry activities;

2.1.b.2. Investigation of forestry activities;

2.1.b.3. Planning of forestry activities, which may include the laying out of roads, developing prescriptions, and selecting acreage or individual trees for present or future timber harvesting and/or timber resource preservation and management;

2.1.b.4. Evaluation of forestry activities; and

2.1.b.5 Responsible supervision of forestry activities.

2.2. Forms of Proof. -- Proof of qualifying experience includes:

2.2.a. Verification on a form provided by the board, signed by the employer or employers, of the dates of all qualifying experience; or verification from the employer by signed letter containing the same information. Letter verification must contain sufficient employer identifying information to permit a check on the employer's standing with respect to lawful state and federal obligations.

2.2.b. Verification on a form provided by the board, signed by at least three (3) professional foresters who have knowledge of the applicant's actual job duties, indicating the actual job duties performed by the applicant, or the equivalent information provided in a signed letter.

**§200-1-3. Approved job titles.**

3.1. A candidate for licensure as a registered professional forester who has completed the minimum educational requirements may file an application pending completion of the experience requirements. Upon receipt of the application and license fee and acceptance by the board, an identification card will be issued certifying that the applicant is a graduate forester who is working toward eligibility for licensing as a registered professional forester in West Virginia. Final action leading to the issuing of a license and certificate of registration will be taken at the first regular board meeting following completion of the minimum experience requirements. A graduate forester who is obtaining qualifying experience for licensure as a registered professional forester may use the title forester or forester trainee.

3.2. A candidate for licensure as a registered forestry technician who has completed the minimum educational requirements may file an application pending completion of the experience requirements. Upon receipt of the application and license fee and acceptance by the board, an identification card will be issued certifying that the applicant is a graduate forestry technician who is working toward eligibility for licensing as a registered forestry technician in West Virginia. Final action leading to the issuing of a license and certificate of registration will be taken at the first regular board meeting following completion of the minimum experience requirements. A graduate forestry technician who is obtaining qualifying experience for licensure as a registered forestry technician may use the title forestry technician or forestry technician trainee.

3.3. Except as specifically permitted in this section, no person other than a person duly licensed as a registered professional forester may use the job titles registered professional forester, professional forester, forester or any other title connoting to the general public that the applicant is a registered forester qualified to perform professional forestry services, and no person other than a duly licensed registered forestry

technician may use the job titles registered forestry technician or forestry technician. The board may at its discretion issue a warning letter when cases of inappropriate use of job titles are brought to its attention and may at any time refer cases for prosecution under W. Va. Code §30-19-10 or apply for injunctive relief as authorized under W. Va. Code §30-1-5.

**§200-1-4. General provisions.**

4.1. The name of this board shall be the state board of registration for foresters. It shall be hereinafter referred to as the board.

4.2. The board shall hold two (2) regular meetings each year in the city of Charleston, West Virginia, or at such other places as may be designated from time to time. One shall be on the second Thursday in April and the other the second Thursday in October. The board may hold such additional meetings as may be necessary, which shall be called by the secretary at the direction of the president or upon the written request of any three (3) members.

4.3. A majority of members of the board shall constitute a quorum for the transaction of its business.

4.4. At a regular meeting in April of each year the board shall elect a president and a secretary, who shall hold their offices for one year and until their successors are elected.

4.5. This seal of the board shall be affixed to all licenses or certificates of registration issued by it. The seal will be two (2) inches in diameter and will contain the words state board of registration for foresters and the state of West Virginia seal.

4.6. The president shall, when present, preside at all meetings, shall appoint all committees, and shall attest all certificates of registration.

4.7. The secretary shall receive and account for all monies in accordance with the statutes and shall attest all certificates of registrations. A record of the board's proceedings shall be kept, as well as other records required by law.

4.8. The order of business of the board shall be as follows:

- (a) call meeting to order
- (b) reading of minutes
- (c) communications (written or oral)
- (d) committee reports
- (e) unfinished business
- (f) new business
- (g) adjournment

4.9. Robert's rules of order shall govern the procedure of the board when not in conflict with the provisions of the by-laws or statutes.

4.10. A majority vote of the board members shall govern the action of the board. The presiding officer shall vote on any motion presented before the board. If only three (3) members are present, then a unanimous vote will be required on any matter presented to the board for official action.

4.11. All authorized compensation and all expenses certified by the board as properly and necessarily incurred in the discharge of its duties shall be paid out of the state treasury, from funds appropriated for that

purpose, on warrants of the state auditor issued on requisitions signed by the president or secretary of the board.

**§ 200-1-5. Registration and licensure.**

5.1. Issuance. - - When the board has determined that an applicant for registration has satisfied the registration standards set forth in this rule, the board shall issue a certificate of registration containing the registered applicant's name and license number.

5.2. Duration. - - Each certificate of registration issued by the board is valid for as long as the registrant is in good standing.

5.3. Renewal. - - The terms for renewal of certification shall be in accordance with W. Va. Code §30-19-7.

5.3.a. Continuing forestry education. - - To renew registration, in addition to all other requirements, a registered professional forester or forestry technician shall attend ten (10) hours of continuing forestry education for each twelve (12) month period since the last renewal or initial registration, as the case may be, or be exempt from these continuing professional development requirements, as provided in this subsection. The board shall not renew registration if the registered professional forester or forestry technician fails to comply with these requirements.

5.3.b. Continuing forestry education hours must be recognized by the Society of American Foresters, a college or university approved by the Society of American Foresters or by the board. One (1) hour of technical forestry instruction shall be equal to one (1) hour of continuing forestry education. Continuing forestry education hours may not carry over for any twelve (12) month period to a subsequent twelve (12) month period.

5.3.c. Reporting and record keeping. - - A registered professional forester or forestry technician shall complete and submit on forms prescribed or accepted by the board certifying the continuing forestry education hours. Forms may be audited by the board for verification of compliance with the requirements. If the board disallows any continuing forestry education hours, unless the board finds following a notice and hearing that the registered professional forester or forestry technician willfully disregarded the requirements of subdivision 5.3.b. then the registered professional forester or forestry technician has six (6) months from notice of the disallowance either to provide further evidence of having acquired the hours disallowed or to remedy the disallowance by acquiring the required units. Hours acquired to remedy a disallowance may not be used to fulfill continuing forestry education requirements for the next renewal period.

5.3.d. Exemptions. - - A registered professional forester or forestry technician is not subject to requirements of subdivision 5.3.a. if (1) the registered professional forester or forestry technician has been granted emeritus or other similar honorific but inactive status by the board or (2) the registered professional forester or forestry technician otherwise meets all renewal requirements and is a civilian called to active duty in the armed forces of the United States, is ill or disabled for a significant period of time or can demonstrate to the board another similar hardship.

5.3.e. The board shall provide forms to be used for reporting compliance with continuing forestry education hours.

5.3.f. A certificate of registration is not transferable.

5.3.g. In the event of the denial, revocation, cancellation, suspension or non-renewal of any certificate

of registration other than board approved retired or inactive status, the registered professional forester or forestry technician shall immediately return the certificate of registration to the board. The applicant or licensee may appeal and the board shall conduct an appeal.

5.3.h. Reinstatement of delinquent registrants: In the event that a registered forester shall fail to pay the annual renewal fee for a period of ninety (90) days following the expiration date of his license, he or she shall be declared delinquent and an additional charge of three dollars (\$3.00) shall be charged for reinstatement of the registration and an additional five dollars (\$5.00) for each additional twelve (12) month period of delinquency, but in no case shall the charge for reinstatement exceed the cost of initial registration. Delinquent registrants whose renewal fee is unpaid as of October 1 will not be included in the published roster of registered foresters for the ensuing year.

5.4. The applicant shall pay a non-refundable fee with the application for registration in the amount of fifty dollars (\$50.00).

5.5. The applicant shall pay the board an annual renewal fee as stipulated in W. Va. Code §30-19-7. The renewal fee upon the effective date of this rule shall initially be fifteen dollars (\$15.00), but may be increased by the board thereafter as provided in that section.

#### **§200-1-6. Code of ethics.**

6.1. The board recognizes that principles for professional conduct are required for registered professional foresters and forestry technicians to ensure confidence, respect and integrity in the forestry profession. The board adopts as a basis for its standards the national code of ethics of the Society of American Foresters. Stewardship of the land is the cornerstone of the forestry profession. The purpose of these canons is to serve as the guiding principles for conduct for registered professional foresters and forestry technicians operating under the laws of West Virginia in their relations with each other, their employers, the public, and other professionals. All registered professional foresters and forestry technicians agree to abide by this code as a condition of registration.

6.1.a. A registered professional forester or forestry technician will advocate and practice land management consistent with ecologically sound principles.

6.1.b. A registered professional forester or forestry technician's knowledge and skills will be utilized for the benefit of society. A member will strive for accurate, current and increasing knowledge of forestry, will communicate such knowledge when not confidential, and will challenge and correct untrue statements about forestry.

6.1.c. A registered professional forester or forestry technician will advertise only in a dignified and truthful manner, stating the services the member is qualified and prepared to perform. Such advertisements may include references to fees charged.

6.1.d. A registered professional forester or forestry technician will base public comment on forestry matters on accurate knowledge and will not distort or withhold pertinent information to substantiate a point of view. Prior to making public statements on forest policies and practices, a member will indicate on whose behalf the statements are made.

6.1.e. A registered professional forester or forestry technician will perform services consistent with the highest standards of quality and with loyalty to the employer.

6.1.f. A registered professional forester or forestry technician will perform only those services for which

the member is qualified by education or experience.

6.1.g. A registered professional forester or forestry technician who is asked to participate in forestry operations which deviate from accepted professional standards must advise the employer in advance of the consequences of such deviation.

6.1.h. A registered professional forester or forestry technician will not voluntarily disclose information concerning the affairs of the member's employer without the employer's express permission or except as may be required by state or federal law or a court of competent jurisdiction.

6.1.i. A registered professional forester or forestry technician must avoid conflicts of interest or even the appearance of such conflicts. If, despite such precaution, a conflict of interest is discovered, it must be promptly and fully disclosed to the member's employer and the member must be prepared to act immediately to resolve the conflict.

6.1.j. A registered professional forester or forestry technician will not accept compensation or expenses from more than one employer for the same service, unless the parties involved are informed and consent.

6.1.k. A registered professional forester or forestry technician will engage, or advise the member's employer to engage, other experts and specialists in forestry or related fields whenever the employer's interest would be best served by such action, and members will work cooperatively with other professionals.

6.1.l. A registered professional forester or forestry technician will not by false statement or dishonest action injure the reputation or professional associations of another member.

6.1.m. A registered professional forester or forestry technician will give credit for the methods, ideas, or assistance obtained from others.

6.1.n. A registered professional forester or forestry technician in competition for supplying forestry services will encourage the prospective employer to base selection on comparison of qualifications and negotiation of fee or salary.

6.1.o. Information submitted by a registered professional forester or forestry technician about a candidate for a prospective position, award, or elected office will be accurate, factual, and objective.

6.1.p. A registered professional forester or forestry technician having evidence of violation of these canons by another member will present the information and charges to the board.

6.2. Proposed amendments to the code of ethics must be adopted by unanimous vote of the board members at any meeting at which there is a quorum present. Proposed amendments are subject to the rule making process as set forth in W. Va. Code §29A-3-1, et seq.

Scope and Purpose. – This rule provides guidance to prospective applicants for licensure and the public regarding the qualifying experience acceptable to the board for candidates for licensure as registered professional foresters and registered forestry technicians, and the approved job titles that may be used by persons obtaining qualifying experience.



Dear Mr. Robards:

Your July 1, 1999, letter concerning the proposed Rules for the West Virginia Board of Registration for Foresters was received and reviewed by the Board. We appreciate your favorable comment regarding the use of titles and the continuing education requirement.

The question you pose about 22-5-3 Approved job titles is really addressed in HB2867. The Bill is very clear that to use the title forester or any other title connoting that an individual performs professional forestry services, they must be licensed. 22-5-3 deals with applicants who use the title forester and have not yet met the minimum experience requirements. In cases such as these, the Board will classify the individuals as a graduate forester and will allow the use of the title while the qualifying experience is being gained.

The other question regarding fees and compensation for an unlicensed individual cannot be addressed by the Rules if the person does not use a title as is described in HB2867. If the title is used and the individual does not obtain a license, then the individual would be subject to Board action described in 22-5-3.3.

On behalf of the West Virginia Board of Registration for Foresters, I wish to thank you for your interest in our profession and for the time you took to review and comment on the proposed Legislative Rules.


The passage of H.B. 2867 and the proposed rules are long overdue and welcome. They add significant meaning to the designation of Registered Professional Forester, especially the use of titles and continuing education requirements. I have two comments regarding the rules. The second one may be outside the scope of the Board's jurisdiction. If so, but you consider it valid, I will be happy to help lobby next year's Legislature for an amendment.

22-5-3 Approved job titles. This appears to restrict companies employing forestry graduates from giving them the company job title of forester if those employees are not registered. I'm not sure I object to that but we should be able to have job titles relative to the employees' forestry education and responsibilities.

I would like to see, in addition to the use of the specified job titles, a rule that prohibits any person not registered from charging fees or accepting compensation of any kind for providing forestry services to anyone other than employers, who should know of their lack of qualifications. This would make the designation a professional license, which is the law in the real estate sales and appraisal, insurance and financial services professions. I feel that the forestry profession is equally important.

If a hearing is scheduled regarding the code as part of the review and comment period, I would like to be notified in order that I may attend.

Your July 2, 1999, letter concerning the proposed Rules for the West Virginia Board of Registration for Foresters was received and reviewed by the Board.

Your question about the two (2) plus two (2) program is being addressed by removing it from the Rules. I recently met with Glenville State College faculty and the provision was not needed to specify qualifying experience for a registered professional forester. The two (2) plus two (2) program is basically terminology used where a student gets a two-year associate's degree in forestry and then continues on for two more years to obtain, most commonly, a bachelor's degree in business or surveying. The Forestry Division of Glenville State College has many students continue on in school following completion of their associate's degree in forestry.

Thanks for pointing out specific canons within the Association of Consulting Foresters of America, Inc.'s Code. The Board discussed various codes of ethics at length, among them were those of the ACF, the Society of American Foresters and other state licensing boards. It was felt that due to the professional diversity of those licensed in West Virginia, the Society of American Foresters' Code provided the best basis, at this time, for developing standards. The SAF is currently in the process of looking at a proposed revision of their code, but it will not get to a vote until late in the Year 2000. Your recommendations will be kept on file for when the Board discusses the West Virginia Code again in 2000 following the SAF action.

§22-5-1. General.

1.1. Scope and Purpose. -- This rule of the state board of registration for foresters is for the purpose of interpreting and implementing W. Va. Code §30-19-1 et. seq., establishing the Board and conferring upon it responsibility for the registration of foresters and the regulation of the practice of professional forestry.

1.2. Authority. -- W. Va. Code §30-1-4 and §30-19-6.

§22-5-2. Qualifying experience.

2.1. Registered professional forester - - An applicant for registration relating to the qualification and registration of professional foresters must have (1) a bachelor's degree in forestry from a four-year school, college or university accredited by the society of American foresters and/or approved by the board and at least two year's of full-time equivalent work experience as a professional forester within the ten years preceding the date of filing an application for registration; or (2) a master's degree in forestry, which is expressly found to fulfill or exceed the requirement of a bachelor's degree, fulfilling course work required for accreditation by the society of American foresters from a school, college or university accredited by the society of American forester and/or approved by the board and at least two years of full-time equivalent work experience as a professional forester within the ten years preceding the date of filing an application for registration; or (3) an associate's degree from a two-year technical forestry program recognized by the society of American foresters, in conjunction with a recognized two (2) plus two (2) program from an accredited college or university, and at least four years of full-time equivalent work experience in the field of forestry acceptable to the board within the ten years preceding the date of filing an application for registration; or (4) an associate's degree from a two-year technical forestry program recognized by the society of American foresters plus a bachelor's degree in another natural science or related field and at least four years of full-time equivalent work experience in the field of forestry acceptable to the board within the ten years preceding the date of filing an application for registration.

*What is a 2+2 program*

Registered forestry technician - - An applicant for registration relating to the qualifications and registration of professional forestry technician must have an associate's degree from a two (2) year technical forestry program recognized by the society of American foresters and at least four (4) years of full-time equivalent work experience in the field of forestry acceptable to the board within the ten years preceding the date of filing an application for registration.

2.1.a. Qualifying experience acceptable to the board is employment that includes both of the following: Employment on a full-time salaried basis, or, at the discretion of the board, equivalent part-time experience, with (1)a business that provides professional forestry services, that is in good standing with respect to all lawful obligations imposed by state and federal law, that employs at least one registered professional forester





The point you make about the availability of training for continuing education should not be a problem. In West Virginia, the Society of American Foresters holds summer and winter meetings which are normally seven or eight hours of CFE's each, the Division of Forestry holds quarterly Stewardship training for consultant foresters which is worth four ± hours each and West Virginia University normally holds forestry meetings around the state which offers CFE credits. When the Board discussed this requirement, it found many state licensing boards used twelve to fifteen required hours; however, based on the diversity of West Virginia and the time it takes to travel around the state, the required CFE's was reduced to ten.

Continuing education requirements are now specified with nearly all professional licensing boards, not only in West Virginia, but across the Nation. It is a duty for all professions to stay current on their profession so the public can expect the best there is to be offered.





Your July 15, 1999, letter concerning the proposed Rules for the West Virginia Board of Registration for Foresters was received and reviewed by the Board.

The Board appreciates your support for the continuing education requirements and the Code of Ethics standards. The point you make about title protection was significantly expanded in our opinion with the passage of HB2867. Basically, HB2867 stipulates that anyone who uses a title that even gives the impression to the public that they perform professional forestry services must first meet the criteria listed for minimum standards of education and experience. In the advent a person does not conform to the Law, the Board may reprimand, prosecute or apply for injunctive relief as stipulated in 22-5-3.3 of the Rules.

The other point you make about a requirement for an apprenticeship may or may not be within the Board's authority. The proposed Rules do address the experience factor in the following sections: 22-5-2.1 – work experience must now be full-time equivalent and be within the ten years preceding the filing of an application for licensing and 22-1-2.1a – work experience must be with a business or government unit that employs at least one registered professional forester in a supervisory position in West Virginia. (This reflects a wording change based on comments during the thirty-day period.) The Board will consult with our Staff Attorney on this question and we may ask you to present your concern at a Board meeting.

In response to your notice of June 30, 1999 regarding the filing of rules for the State Board of Registration for Foresters, I would like to offer the following.

I applaud the action of the Board in implementing the changes, particularly in the requirement for Continuing Education Credit and the adoption in the Code of Ethics. While I support these changes, I feel the proposed rules lack one very important element.

The current registration procedure for the State of West Virginia is still only title protection of the title of Registered Professional Forester, Professional Forester, or Registered Forestry Technician. This title protection does not provide any assistance to the citizens of West Virginia in the protection from non-professional activities by Foresters who have not voluntarily elected to become Registered Foresters or Forestry Technicians under the West Virginia Code 22-5-1. Because registration in West Virginia is still voluntary, the new rules will effect only those of us who have the professional ethics, experience, and desire to be qualified as a Registered Forester or Forestry Technician.

Our profession needs to "clean up its act" and eliminate the problems of misrepresentation and non-professional activities by inexperienced or unethical Foresters and Forestry Technicians. The Board must enact mandatory registration for all Foresters and Forestry Technicians operating in the State of West Virginia. If the Board does not mandate registration, then the implementation of these rules, as well as, work done this past spring during the Legislative Session will have been a waste of time.

Further, the Board needs to require an Apprenticeship or Forester-in-Training, similar to that of licensed land surveyors. This apprenticeship should be equal to the number of years experience required to qualify for licensing as a Registered Forester or Registered Forestry Technician. I feel this is the only way to prevent inexperienced persons from representing themselves as knowledgeable and competent Foresters or Forestry Technicians.

I hope the Board recognizes the importance of developing a true Forester / Forestry Technician Registration requirement rather than just title protection. Also, I hope the Board will take the appropriate and necessary steps to revise the current and proposed regulations to resolve the problems which exist at this time.

Thank you for sending a draft of the proposed litany of legislative regulations as proposed by the Board. Everyone sees things differently. As you know, all anyone wants is a fair majority. Such may come up as these regs. pass through the six or so legislative committees' early next year. Since there will be at least two meetings of the Board before any legislative rule can be certified, it may be necessary to file the interpretative rule as provided for in the implementing legislation.

I do not plan to be for or against any reg. unless it is unworkable, unenforceable or definitely not in the best interest of forestry. I am using this letter strictly to point out some areas of concern, which have been called to my attention. I have checked with several foresters, although not all are registered foresters.

Under 22-5-2.1, the insertion of "and/or" approved by the board would seem to be a change of the statute, HB 2867, as passed and signed into law. Why have the well understood SAF criterion if the Board can override it? Also, shouldn't the Board insist on knowledge of the curriculum that is followed? Will a degree in Limnology suffice even if from a school of forestry? How about a degree in Recreation given by a school of forestry? Would it be better to specify the hours and subjects needed, i.e., Dendrology, 6 or whatever hours; Silviculture, etc.; forest soils, etc.; forest measurements, etc; as is now done by the Board?

In the same paragraph, a master's degree is discussed. The same comment applies as to "and/or." This opens the Board up to criticism and political manipulation.

In 2.1.a, I would suggest that the term "work" be placed between "Qualifying" and "experience." I would doubt that the salaried requirement would stand if challenged. To exclude "hourly" personnel may be interpreted as discrimination. You may also want to consider some types of self-employment. I would suggest adding "in a supervisory position" after "forester," in the last line of page 1. You might also want to restrict it even more. For example, what good is a registered forester working for a company in Georgia doing to do for a candidate working in West Virginia? Under subsection (2) of that unit (top of page 2), I would suggest inserting "that provides professional forestry services and that" after the word "government" and again would add "in a supervisory position" after the word "forester."

Gillespie to Lilly on Bd. of Reg. Regs. 2

Under 2.1.b, the words "in consultation" might take care of the self-employed.

Under 3.1, I doubt that a governmental title will take precedence over a company title. If Coastal calls their graduate foresters "foresters," I doubt if the Board can prevent it, if agencies are allowed the freedom to do so. Actually, it might come down to the Courts saying that the title comes with the diploma. It also could come down to whether the forester in question is being paid by a client. If the work is "for hire," it might be interpreted differently. The 'trainee' term, if all-inclusive might be the out for the agency. The same general comments have come up about 22-5-3.2.

Under 4.7, the terminology should be "receive and account."

Under 5.2, I doubt if the Board wants to send out a certificate annually. Why not something like "Each certificate of registration issued by the board is valid as long as the registrant is in good standing."

Under 5.3, I would suggest substituting "certification" for "certificate of registration."

Under 5.3.a, some will argue against anyone being exempted from the continuing forestry education, even retired members, unless they drop their certification. Under 5.3.g, there should be some way for retirees to keep the certificates as souvenirs. Or you could send them a different certificate saying they were certified members for so many years.

Dave, I have seen regs. picked to pieces several times. They need to be tight and in conformance with the law.
