### PETITION FOR CHILD SUPPORT

Comes now the West Virginia Department of Health and Human Resources, Bureau for Child Support Enforcement, by Counsel, who alleges as follows:

1. This petition is pursuant to West Virginia Code. The BCSE Attorney represents the interest of the State of West Virginia.
2. Cheyene Bosserman is the physical custodian of the minor child(ren), Layla Tierney born on December 10, 2015.
3. Cheyene Bosserman and the minor child(ren) reside in Hardy County, West Virginia.
4. Christopher Tierney resides in Culpeper County, Virginia.
5. Christopher Tierney is a parent of the minor child(ren) and owes a duty of support to said child(ren) that is not being fully met. Christopher Tierney is not the physical custodian of the child(ren).
6. Upon information and belief, there is no pending action for divorce, separate maintenance or annulment in which the obligation of support owing from Christopher Tierney to the child(ren) is at issue.
7. Upon information and belief, there is no order of support against Christopher Tierney.
8. Cheyene Bosserman has applied for services from the Bureau for Child Support Enforcement or receives mandatory services for the child(ren).
9. If any public assistance benefits have been received, the State of West Virginia is subrogated to the rights of Cheyene Bosserman, to receive reimbursement and/or current support
