In addition to the amount set forth in this writ of execution, the sheriff may also collect a commission as provided by law. W. Va. Code § 59-1-14.

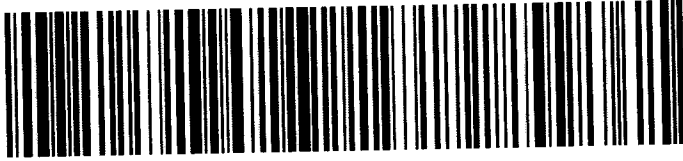
