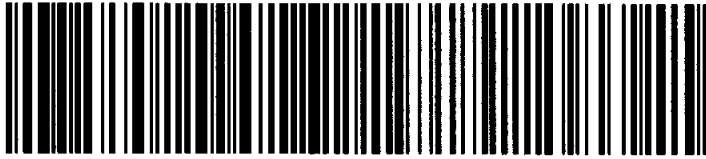

(If the judgment debtor's wages, after deducting state and federal taxes, do not exceed 50 times the federal minimum hourly wage, then no amount shall be withheld.)
