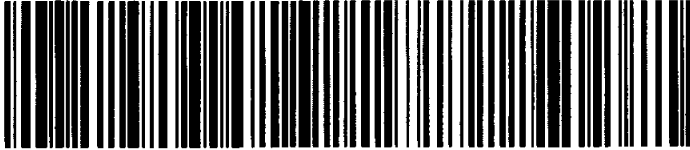

WHEREAS, in an action in the Circuit Court of Preston County, West Virginia, Monongalia County General Hospital Co. d/b/a Monongalia General Hospital, on November 17, 2015, recovered a judgment against Carrie L. Cole (SSN: 235-31-4267) for the sum of \$5111.06 and court costs, with interest on the principal sum from the date of judgment, until fully paid;

AND WHEREAS, an affidavit or satisfactory proof has been filed in my office that weekly disposable earnings\* are now, or will hereafter, within one year from this date, become due the judgment debtor from, Lowe's Companies, Inc., ATTN: Payroll Department, whose address is Post Office Box 1111, North Wilkesboro NC 28656, his employer, in excess of thirty times the federal minimum hourly wage in effect at the time the earnings are payable.

THEREFORE, you are commanded, in the name of the State of West Virginia, to levy for the amount due on said judgment upon twenty per centum of the disposable earnings of the judgment debtor, now due or to become due within one year from this date from said employer, provided such levy will not reduce the disposable earnings remaining to the debtor after levy below thirty times the federal minimum hourly wage in effect at the time the earnings are payable, and receive and collect from the above-named employer, for the benefit of the judgment creditor, the per centum aforesaid of the said disposable earnings, and make return of your proceedings hereunder to the Clerk of said Court within twenty (20) days after the expiration of the one-year period.
