## Statement of Waiver

### For Candidates, Political Action Committees, or Political Party Executive Committees Exempt From Filing An Annual, First Primary or First General Campaign Finance Report

Candidates and committees who receive and/or spend less than \$500.00 during the above reporting periods do not have to file a financial report. The annual reporting period begins on the last Saturday in March and continues for 6 days. In an election year, the report is called the "first primary" report for candidates who plan to run in the primary election. The first general reporting period begins on the first Saturday in September and continues for 6 days.

Candidates who do not have to file a financial report may instead file a Statement of Waiver. This Statement of Waiver tells the public and press that the candidate is not required to file a financial report.

**NOTE: THE STATEMENT OF WAIVER CANNOT BE FILED IN PLACE OF ANY PRE-PRIMARY, POST-PRIMARY, PRE-GENERAL, OR POST-GENERAL ELECTION REPORT.**

Due last Saturday in March or within 6 days thereafter. This report filed for old campaigns or year following most recent election.

☐ **First Primary:**  
Due last Saturday in March or within 6 days thereafter. This is the first report for current election year reporting.

☐ **First General:**  
Due first Saturday in September or within 6 days thereafter preceding general election
