

State of West Virginia Statement of Waiver

For Candidates, Political Action Committees, or Political Party Executive Committees Exempt From Filing An Annual, First Primary or First General Campaign Finance Report

To qualify for a waiver a candidate or committee must meet the following requirements:

To waive the Annual Report or the First Primary Report during an election year, candidates and committees must have received and/or spent less than \$500.00 during the reporting period. (West Virginia Code §3-8-5(b)(1))

To waive the First General Report, candidates and committee must have received and/or spent less than \$500.00 during the reporting period **AND** not have any outstanding loans. (West Virginia Code §3-8-5(b)(4))

Candidates who do not have to file a financial report may instead file a Statement of Waiver. This Statement of Waiver tells the public and press that the candidate is not required to file a financial report.

NOTE: THE STATEMENT OF WAIVER CANNOT BE FILED IN PLACE OF ANY PRE-PRIMARY, POST-PRIMARY, PRE-GENERAL, OR POST-GENERAL ELECTION REPORT.

Please check appropriate box to indicate which report you are filing.

Annual Report 2005 Calendar Year
Due last Saturday in March or within 6 days thereafter. This report filed for old campaigns or year following most recent election.

First Primary:
Due last Saturday in March or within 6 days thereafter. This is the first report for current election year reporting.

First General:
Due first Saturday in September or within 6 days thereafter preceding general election

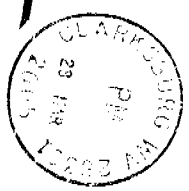
